QUALIFICATION:

For Generator Operator

Candidate should have passed matriculation examination from a recognized Board or its equivalent, with knowledge of Hindi or Punjabi or Sanskrit, possessing ITI Trade Certificate in Electrician from any Government Institute or its equivalent and two years' experience in operation and maintenance of generators.

For Lift Operator

Candidate should have passed matriculation examination from a recognized Board or equivalent, with knowledge of Hindi or Punjabi or Sanskrit, possessing ITI Trade Certificate in Electrician from any Government Institute or its equivalent and two years' experience in operation and maintenance of lifts.

AGE LIMIT

18 to 42 years as on 01.01.2025. Relaxation in upper age limit as per rules.

DATE OF INTERVIEW:

For the posts of Generator Operator : 24.02.2025

For the post of Lift Operator : 25.02.2025

HOW TO APPLY


